Non-Profit Status

Notwithstanding any other provisions of these By-Laws, the Club shall carry out activities permitted by an organization exempt from Federal income tax under Section 501 © of the Internal Revenue code of 1954 or the corresponding provision of any United States Internal Revenue Law or by an organization, contributions to which are deductible under Section 170© (2) of the Internal Revenue code of 1954 or the corresponding provisions of any future United States Internal Revenue Law.
